I am directed to refer your proposal for Increase of seats in MD (Community Medicine) course at Madras Medical College, Chennai, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956.

It is to inform that the then Postgraduate Medical Education Committee of this Council at its meeting held on 21st August 2018 considered the Council Assessor's report (13th July 2018) on the physical and other teaching facilities available at Madras Medical College, Chennai, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai for Increase of seats in MD (Community Medicine) course u/s 10A of the IMC Act, 1956 for the academic year 2019-20 and the Committee decided as under:

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (13th July 2018) and decided to recommend to the Central Govt. to issue Letter of Permission for Increase of seats in MD (Community Medicine) course at Madras Medical College, Chennai, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2019-20 from 4(Four) to 10(Ten) students per year till the first batch admitted against the increased number appears in the final examination of the said course.
