It is to inform that the Board of Governors considered the Council Assessor's report (10th April 2019) together with the recommendations of the PG Expert Group (BoG) on the physical and other teaching facilities available at Madras Medical College, Chennai, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai for Starting of DM (Clinical Haematology) course u/s 10A of the IMC Act, 1956 for the academic year 2019-20 and decided as under:

"The Board of Governors considered the Council Assessor's Report (10th April 2019) together with the recommendations of the PG Expert Group (BoG) and decided to issue Letter of Permission for Starting of DM(Clinical Haematology) course at Madras Medical College, Chennai, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the I.M.C.
